Michèle Lamont is Professor of Sociology and of African and African American Studies and the Robert I. Goldman Professor of European Studies at Harvard University. A cultural and comparative sociologist, she is the author or coauthor of a dozen books and edited volumes and over one hundred articles and chapters on a range of topics including culture and inequality, racism and stigma, academia and knowledge, social change and successful societies, and qualitative methods. Her book "Who Matters; How to Redefine Worth in our Divided World" will be published by Simon and Schuster (US) and Penguin (UK) in 2023. She is also co-chairing the advisory board to the 2021-22 UN Human Development Report, "Uncertain times, Unsettled Lives: Shaping our Future in a World in Transformation." After directing the Weatherhead Center for International Affairs at Harvard University from 2014 to 2021, she leads its research cluster on Comparative Inequality and Inclusion. Recent honors include a Carnegie Fellowship (2019-2021), a Russell Sage Foundation fellowship (2019- 2020), the 2017 Erasmus prize and honorary doctorates from six countries. She served as the 108th President of the American Sociological Association in 2016-2017.

Early Careers Conference

This is a closed event and is not open to all participants of the conference.

This year's Early Careers Conference will explore aspects of "Reflective Migration Research in Quantitative and Qualitative Methods". Reflective migration research shall challenge common categories of migration and integration studies against the background of social- and political assumptions, conditions, and its consequences. This concerns issues such as the reproduction of social exclusion and methodological nationalism as well as the categorisation of migration itself. In addition to the parallel workshops and its different methodological approaches, we would like to bring participants into a dialogue including joint poster presentations. Afterwards, there will be space for further networking during a get-together.

Workshop 1: Critical and reflective migration research with quantitative methods

Organisation: Philipp Jugert (InZentIM), Sauro Civitillo (InZentIM)

How to best capture participant heterogeneity related to ethnicity, race, religion, heritage, and culture poses an ongoing dilemma for researchers focusing on migration and integration. In the European context, the widespread use of 'migration background' has been criticized for its lack of theoretical and sociocultural relevance. People with 'migrant background' are extremely heterogeneous with regards to salient identity markers such as family heritage, religion, access to formal citizenship, or cultural identification, and despite this often grouped solely by their non-native heritage. Alternative social constructs such as race and ethnicity are legally problematic in the European context and may reinforce a priori notions of differences. In this workshop, participants will be encouraged to examine variability within social categories when applied to study migration phenomena using quantitative methods. Centering on QuantCrit (Garcia et al., 2018; Gillborn et al., 2018), a framework for using quantitative research that draws on critical race theory (CRT), this workshop aims to improve participants` understanding of the centrality of racism; the acknowledgment that numbers are not neutral; the reality that categories are neither 'natural' nor given; the recognition that voice and insight are vital: data cannot 'speak for itself'; and that statistical analyses have no inherent value but that they can play a role in struggles for social justice. The workshop will include keynote talks by Prof. Moin Syed (University of Minnesota, USA) and Dr. Anne-Kathrin Will (HU Berlin).

Workshop 2: Between care and harm.

How can we (self)reflexively study the production of knowledge on migration?

Migration researchers, International Organisations, migrants, activists, governments, police, NGOs, (social) media – there are countless knowledge producers who shape the ways in which migration is made thinkable, countable, governable, and researchable. This workshop will explore how qualitative (migration) researchers can (self)reflexively study the production of knowledge on migration. Based on (self)reflexive techniques developed in feminist Science and Technology Studies and Critical Migration and Border Regime Research, we argue that doing (self) reflexive migration research leads us to address questions of "thinking with care" (Puig de la Bellacasa 2012) and doing (no) harm. Migration research handbooks, ethics committees and method chapters are full of cautious advice and self-reflection when research is done about or with migrants. Critical migration scholars highlight the social, economic and political gap between researchers and researched and sensitize for the power relations at play and their effects on the knowledge produced. They call for the researchers' responsibility towards the people they are studying. However, what has received far less attention, is the question how we must rethink care and harm in research ethics when we do not research migrants but those who produce knowledge on migrants or migration.

Keynotes of the Early Careers Conference



Prof. Dr. Moin Syed, University of Minnesota, is a cultural developmental psychologist with broad interests in identity and personality development among adolescents and emerging adults from diverse ethnic, racial, and cultural backgrounds. Historically his work has focused on 1) how individuals' identities, represented via personal narratives interface with culturally-available master narratives, and 2) how youth integrate their multiple identities, with an emphasis on how ethnic identity intersects with other identity domains (e.g., gender, sexuality, education). In the last several years, his research program has focused primarily on methods and practices used in psychology within the broad framework of open science and meta-psychology (research on how psychology operates as an academic discipline), especially in the context of developmental and ethnic minority psychology.



Dr. Anne-Kathrin Will teaches at the Institut für Europäische Ethnologie der Humboldt-Universität zu Berlin and is associated member of the DeZIM-Institute as well as the BIM-Institute. She obtained a PhD in European Ethnology in 2009. After graduating in 2002, Anne-Kathrin worked at the Technische Universität Dresden and subsequently in scientific policy advice in the areas of integration, vocational training, and equality. This was followed by an employment at the office of the Expert Council of German Foundations for Integration and Migration where she was responsible for an integration barometer from 2009 to 2013, at the Otto-von-Guericke Universität in Magdeburg and at the Humboldt Universität zu Berlin. Anne-Kathrin has been involved in a different areas of scientific monitoring and evaluations and is interested in humanitarian work, the operationalization of migration, discourses on belonging, and the representation of minorities.

Maurice Stierl Maurice Stierl leads the research group "The Production of Knowledge on Migration" at the Institute for Migration Research and Intercultural Studies, Osnabrück University. Before, he was a lecturer in International Relations at the University of Sheffield. Maurice Stierl has also taught at the University of Warwick and the University of California, Davis. His research focuses on migration struggles in contemporary Europe and (northern) Africa and is broadly situated in the fields of International Political Sociology, Political Geography, and Migration, Citizenship and Border Studies. His book "Migrant Resistance in Contemporary Europe" was published by Routledge in 2019.



Rachid L'Aoufir holds a joint doctoral degree in history from the School for Advanced Studies in the Social Sciences in Paris and the Freie Universität Berlin. He graduated from Edhec Business School. Rachid is passionate about initiating and conducting institutional change. As a civil society leader and a practitioner he is involved in transnational youth help and in facilitating the dialog between diaspora organisations and public authorities. In this field, he conducts studies on behalf of public administrations. Rachid, who is a sharp minded speaker, also chairs the African-German Working Community, an umbrella organisation of the African-German civil society.

Context

Since the beginning of the Russian attack in February 2022, many people have fled from Ukraine to Germany: according to the central register of foreigners more than 870,000 Ukrainians were registered in Germany by the end of June 2022. The **vast majority are women (67%)** accompanied by children (38%) or seniors.

The arrival of **refugee women from Ukraine** poses a new challenge for German **integration policy** as a crosscutting issue. After their arrival in Germany, refugee women are confronted with many hurdles and burdens such as psychological trauma of fleeing but also worries about relatives who are left behind. In addition, there are different language skills, a lack of social networks, and difficulties in having **professional qualifications** recognised as well as the general **gender bias**.

The prerequisites for rapid **integration into the German labour market** are nevertheless good. Women from Ukraine are well educated, have already worked in Ukraine or were in training. Initial surveys show that they would like to work as teachers or nurses in Germany. But first they have to learn German and have their **qualifications recognised**.

Discussion

The Forum takes an intersectional view at the integration of refugee women from Ukraine in Germany. Representatives from science, politics, and civil society will discuss the following questions: What preliminary conclusions can be drawn for refugee women from Ukraine after more than 6 months? Which structures have proven themselves since 2015, which propositions are currently required? What are the special needs of refugee women and children? How do institutions such as day care centres and schools, municipal administration or economic actors deal with this challenge?

Welcoming



Dr. Noa Ha is an urban researcher, visiting lecturer at the Weissensee Kunsthochschule Berlin and associated researcher of the National Discrimination and Racism Monitor (NaDiRa) at the DeZIM Institute. From July 2020 to September 2021, she was the acting Scientific Director at the DeZIM Institute and from October 2021 to March 2022, Noa K. Ha headed the NaDiRa office. From 2018 to 2020, she led the Center for Integration Studies at TU Dresden as Executive Director and Junior Research Group Leader, and before that she was a Research Associate and Post-Doc at the Center for Metropolitan Studies (CMS) at TU Berlin from 2013 to 2017. Noa K. Ha's work focuses on postcolonial urban studies, migrant-diasporic memory politics, critical integration studies and the critique of racism.

Dr. Yuliya Kosyakova joined IAB as senior researcher in April 2016. At the IAB, she coordinates the IAB-BAMF-SOEP Survey of Refugees (together with Herbert Brücker) and leads the IAB working group "Consequences of the COVID-19 Pandemic" (together with Laura Pohlan). Since 2020 she has been an associate lecturer at the University of Bamberg. Between 2019 and 2020 she has been a lecturer at the University of Mannheim. She studied Economics (European Economic Studies, MSc) at the University of Bamberg and received her PhD in Sociology at the European University Institute (EUI) in Florence in 2016. Between 2011 and 2016, she was part of the research team at EUI on the research project eduLIFE. Her main research interests relate to labor market and employment research, migration and refugee research, international comparison, social stratification, gender inequality, life course research, and quantitative data analysis.

Dr. Gunilla Fincke is Head of the Department of Skills, Vocational Training and Securing a Skilled Labour Force at the Federal Ministry of Labour and Social Affairs (BMAS). Before joining the BMAS, she was Head of the Policy Department of the SPD Party Executive Committee from 2014 to 2018 and previously worked for six years as Managing Director of the Expert Council of German Foundations on Integration and Migration.



Anja Piel is a member of the Federal Executive Board of the Confederation of German Trade Unions (DGB). Since 2020, she has also been the alternating chair of the administrative board of the Federal Employment Agency (BA) and the Federal Board of the German Pension Insurance Federation (DRV). In her role on the executive board of the DGB and among other things, Mrs. Piel's responsibilities include labour market policies, social policies and law as well as migration and anti-racism policies. Anja Piel understands her mandate as a part for a more socially fair society and puts her heart and soul into concrete implementations of this goal.



Prof. Dr. Magdalena Nowicka is Head of Department Integration in the DeZIM Institute and honorary professor in the Institute of Social Sciences at the Humboldt University in Berlin. Nowicka is a sociologist with interdisciplinary background in political science and cultural studies from Poland and Germany. Her research interests are migrant transnationalism in Europe, diversity, conviviality and racism. Her recent publications include the book "Revisualising Intersectionality" (Palgrave, 2022, with Elahe Haschemi Yekani and Tiara Roxanne). Currently at DeZIM she is the PI of the project on subjective perspectives of Ukrainian forced migrants in Germany.



Dr. Natalia Roesler studied German and later did her doctorate in German and Political Science at the Westfälische Wilhelms-University Münster as a doctoral scholar of the Friedrich-Naumann-Foundation. Natalia Roesler has been involved in integration and education work since 2006. First as head of the first integration language courses in Nuremberg, later as project manager of various integration projects and managing director

of Club Dialog e.V. Dr. Roesler has been a board member of the Federal Association of Russian-Speaking Parents (BVRE) since 2017, board member of the Federal Parents' Network of Migrant Organizations for Education & Participation (bbt) since 02/2021 and is active in numerous other integration committees. Her special interests are the integration of women, support for migrant parents, work with children and young people, and education.


Venue
